As we continue to focus on raising the bar on the quality of our support for your efforts, Pfizer uses a quarterly review process for healthcare charitable contribution requests submitted via the website at [www.pfizer.com/healthcharitables](http://www.pfizer.com/healthcharitables). Requests should be submitted according to the quarterly schedule noted below.

Pfizer strives to communicate decisions no later than the date indicated for each respective application cycle. Requests may still be submitted in between application periods; however, they will not be considered until the next application cycle (e.g., a submission on February 10 will be reviewed along with those requests submitted during the Mar 1 – Apr 15 cycle). It is important to note that the program/activity date should commence according to the estimated start dates noted above to allow adequate time for review, communication of decisions and execution of the letter of agreement (LOA).
